Snowy River Project Update - January 2024

Federation Mining is pleased to provide an update on our progress at the Snowy River Gold Mine near Reefton on the South Island in New Zealand.

Project Update

Federation was pleased to exercise the option to purchase the Snowy River Mine from Oceana Gold. This transaction which is subject to several conditions including regulatory approval is expected to close later this year. Read the full media release <a href="https://exercises.org/lease-purch

Federation is expecting to have a Mineral Resource & Reserve (MROR) statement available in the coming month.

The Company continues to progress opportunities for project funding for the future phases of the project.

Operational Update

Underground crews continued to work on development of the locations marked for trial mining with 199 metres of decline developed. Dewatering of the historic workings of the Blackwater Mine (above our operations known as the Snowy River Mine) will commence in the coming months.

A total of 561 m of underground drilling was completed in the month bringing the total resource development drilling completed (project to date) to 15,476.3m. We have one rig drilling underground, drilling a program of holes testing the northern end of the Birthday Reef. The rig will then commence drilling a dewatering hole into the Prohibition Shaft next month.

During the month we appointed a new Site Electrical Supervisor and hired several trades roles.

Environment

All environmental compliance monitoring was completed, and results were compliant. The planting for the rehabilitation of side of the waste rock stack has established well.

Recruitment

The Snowy River project is fully permitted to allow the construction and operation of an onsite processing plant. During the operational phase the site is expected to employ over 140 people with the first full quarter of production in 2025.
